For annotated bibliographies, use standard APA format for the citations, then add a brief entry, including: • 2 to 4 sentences to summarize the main idea(s) of the source. - What are the main arguments? - What is the point of this book/article? - What topics are covered? • 1 or 2 sentences to assess and evaluate the source.

An annotated bibliography is the same as a “regular” bibliography (also known as a Works Cited or References list), with the addition of annotations (short paragraphs about each source). Two types of annotated bibliographies are the most common: Descriptive: annotations describe the content of a source
