No ocular involvement.

CHAPTER 6
The physical examination must include a thorough inspection of the overlying soft tissues (with documentation). If the fracture is open, a clinical photograph may be taken for documentation purposes and to avoid multiple clinicians having to take down dressings to observe the wound.
